Charge up with clean, American made electricity. Businesses that promote the charging infrastructure for electric vehicles by installing a Level 2 or larger charging station for public/employee use are eligible for a \$500 rebate. In addition, your business can receive a rebate for one year's worth of Renewable Energy Credits to offset 100% of your total energy usage with renewable energy.

\$500 Rebate and 12-Month Renewable Energy Credits

- Businesses can receive a \$500 rebate to help cover the costs of installing a Level 2 or larger EV charging station for public/employee use. Rebate cannot exceed the purchase/installation costs of equipment.
Members can opt to receive a rebate for a complimentary 12-month Renewable Energy Credit (REC) subscription for 100% of their energy use to come from renewable sources.

How to Apply for Rebate

- Fill this form out completely. Incomplete forms will not be processed.
A copy of proof of purchase/invoice and documentation verifying equipment purchase and installation cost must be included. Documentation will not be returned.
Submit the completed rebate form by December 31, 2020.
Each account is eligible for one rebate. Rebate cannot exceed total cost of equipment.
