#### Save up to \$500 on a Level 2 Charger!

- ▶ Members can receive a rebate to help cover the costs of a Level 2 EV home charger including installation. Receive up to a \$250 rebate with enrollment in Plug-in Rate (sub-meter) or up to a \$500 rebate with enrollment in Time of Use rate. Rebate cannot exceed the cost of the charger and installation.
- ▶ Qualifying Level 2 (240-volt outlet) charger up to 7.5 kW at a home receiving electricity from SVE. Charger must be purchased and installed in 2019, meet all applicable codes and used with a plug-in EV.
- ▶ Refer to current rate schedules for more details on Plug-in and Time of Use rates. If you choose to go off TOU rate and later request an installation of a sub-meter for alternative plug-in program, there will be a \$200 installation charge.
- ▶ Members can opt to receive a complimentary 12-month Renewable Energy Credit (REC) subscription for 100% of their energy use to come from renewable sources. They can choose to subscribe on their own and at what percent of usage after the 12-months expire.

### How to Apply for Rebate

- ▶ Fill this form out completely. Incomplete forms will not be processed.
- ▶ A copy of proof of purchase/invoice and documentation verifying equipment purchase and installation cost must be included. Documentation will not be returned.
- ▶ Submit the completed rebate form by December 31, 2019.
- ▶ **Each account is eligible for one rebate.**
